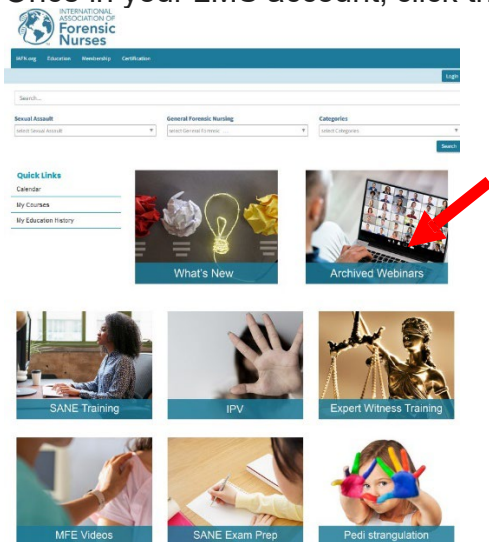




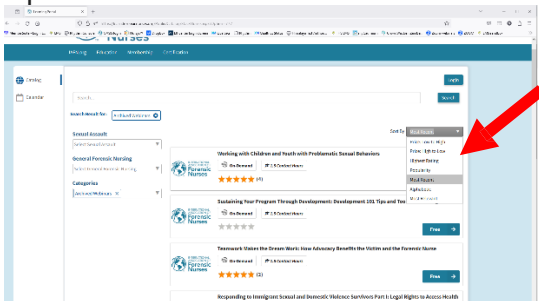
# INTERNATIONAL ASSOCIATION OF Forensic Nurses

To access the webinar with CEUs please follow these steps:

1. Enter the IAFN LMS site [here](https://learn.forensicnurses.org/Catalog/IAFN) (https://learn.forensicnurses.org/Catalog/IAFN)
2. This will take you to the catalog. If you are not yet logged into your IAFN account, click the teal Login button at the top right to log in.
3. Once in your LMS account, click the *Archived Webinars* block.

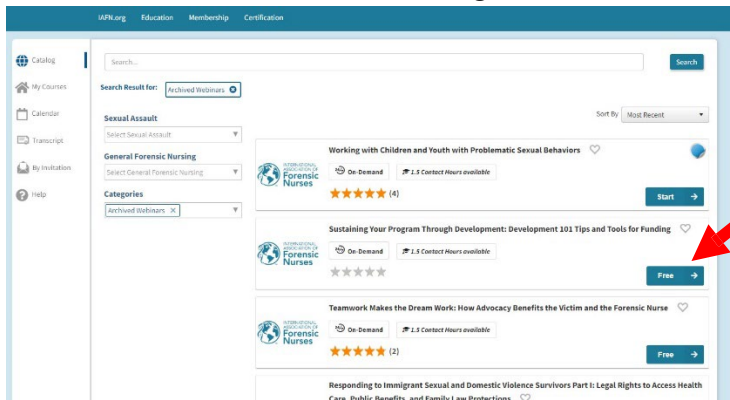


4. You can simply scroll down to find the webinar OR select “sort by” and choose most recent or alphabetic

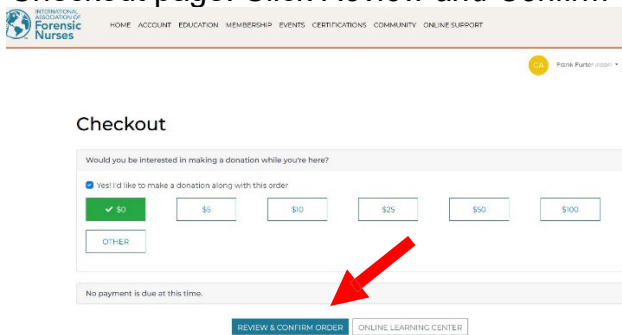


5. Look for the webinar that you just attended with (example – “The Role of the Registered Nurse at the Child Advocacy Center”)

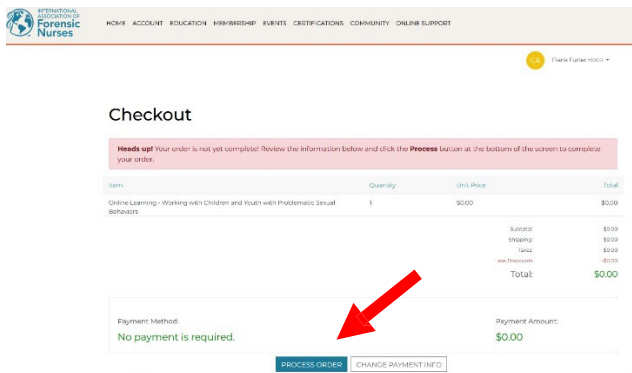
6. Click the teal *Free* button to the right of the webinar name.



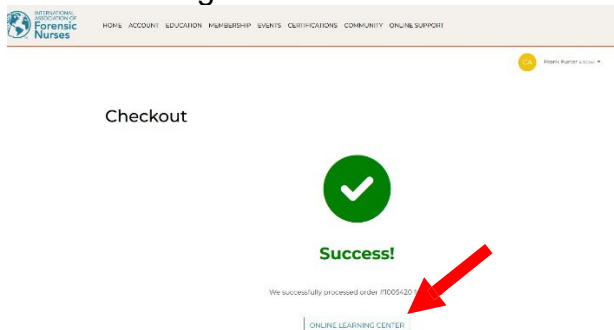

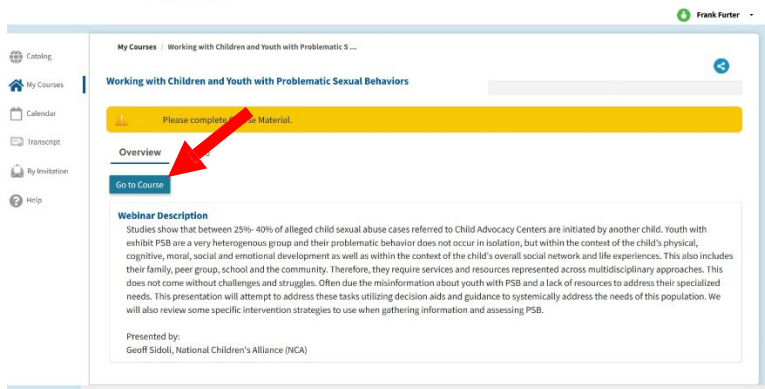
8. The next page is the summary page. Make sure to click the teal **PROCESS ORDER** button at the bottom.



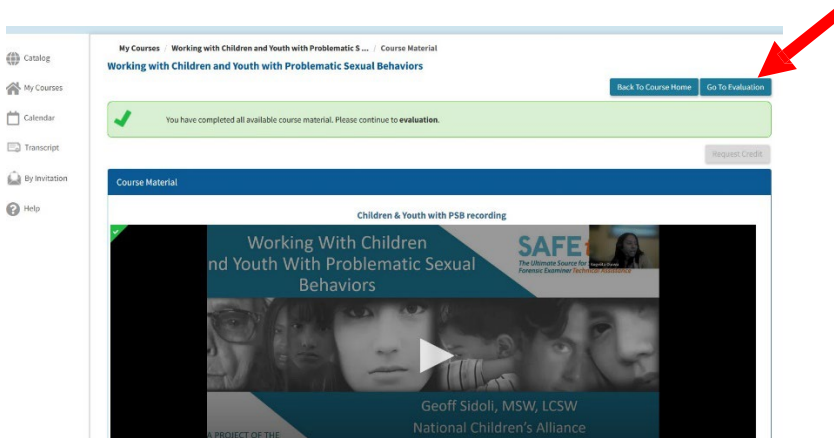
9. You will see a green **Success!** once completed. Click the Online Learning Center button at the bottom to go back to the webinar.



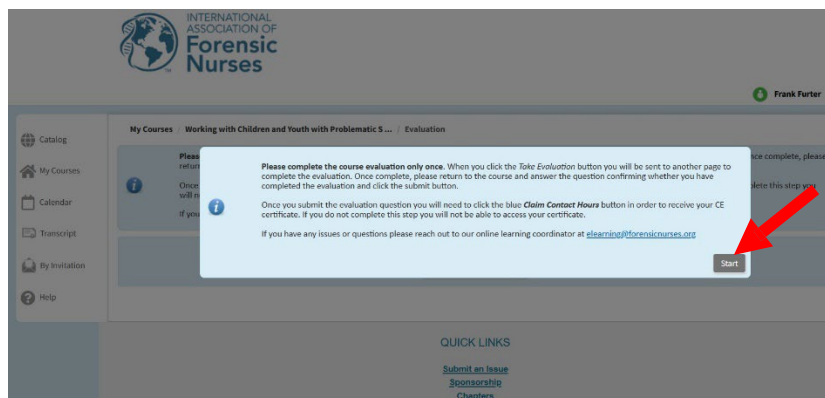
10. You will be brought to the webinar. Click *Go to course* to begin.



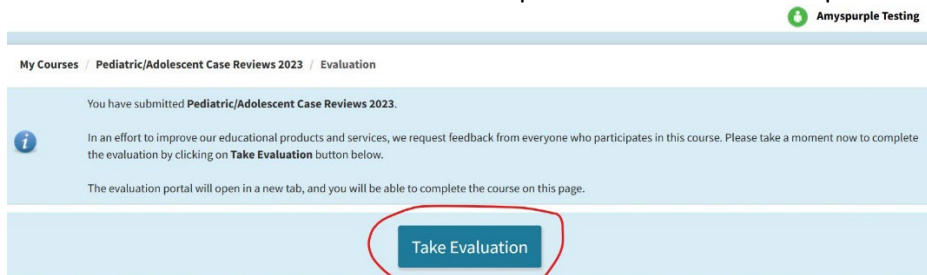

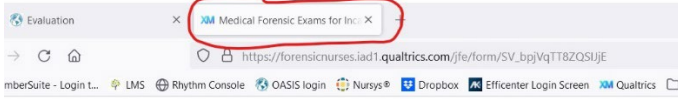
12. A pop-up will appear with evaluation instructions. Click the Start button in the bottom right corner.

14. Once you complete and submit the evaluation, close that tab. You should be back on the “take evaluation” page but with an additional question below the Take Evaluation button.




